## **RESOLUTION NO. 2017-69**

A RESOLUTION OF THE VILLAGE BOARD OF THE VILLAGE OF CALEDONIA TO ADOPT MAP ENTITLED CHILD SAFETY ZONE MAP SHOWING THE CHILD SAFETY ZONES FOR SEX OFFENDERS UNDER SEC. 11-2-16 AND TO SET THE FILING FEE FOR AN APPEAL UNDER SEC. 11-2-16(g)

OF THE CODE OF ORDINANCES OF THE VILLAGE OF CALEDONIA

The Village Board for the Village of Caledonia resolves as follows:

## **RECITAL**

WHEREAS, in 2008, the Village Board determined that it was necessary to adopt n ordinance to regulate where sex offenders could reside within the Village in relation to certain locations where children are known to congregate and based on such determinations, the Board adopted Section 11-2- of the Code of Ordinances.

**WHEREAS**, the Village Board has determined that it was necessary to revise Section 11-2-16 and to update the associated mapping.

**WHEREAS**, the Village Board conducted first and second readings of an ordinance to amend Section 11-2-16 on August 4, 2017, and adopted the ordinance on August 4, 2017.

WHEREAS, pursuant to the authority under Sections 11-2-16(c)(3), the Village Board is required to adopt a map from time-to-time showing the Protected Locations and Child Safety Zones as those terms are defined under the ordinance. This map is a tool that the Village chooses to utilize to provide notice to the public of the requirements of the Ordinance.

WHEREAS, the Village Engineering Department, in conjunction with the Village Police Department, has prepare a revised map consisting of one page showing the Protected Locations and Child Safety Zones as those terms are defined under the ordinance and the resulting residency distance restrictions for 1500 feet per the ordinance. This new map labeled "Child Safety Zone Map" consists of one page and is attached hereto as Exhibit A.

WHEREAS, the Protected Locations that are identified on the map include: School Property, Day Care Center, Library, Park, Recreational Trail, Playground, Athletic Fields used by children, Place of Worship, Swimming Pool, the Village's East Side Community Center, and any other place designated in the Map as a place where children are known to congregate.

WHEREAS, the Map includes the kinds of locations identified above as well as businesses and other places where children are known to congregate such as Yogi Bear Jellystone Park, Mulligan's Mini Golf and McDonald's (because of the playland) as well as properties owned by nonprofits that are regularly utilized by children such as the recreational trails and other properties such as the Trout Ponds owned by the Caledonia Conservancy. The Map also includes places where children are known to congregate for recreational activities and camps that are privately owned such as the Soccer Complex of Racine (Score) and the ECO Justice Center.

WHEREAS, Section 11-2-16(g)(3) of the Village's Code of Ordinances, requires the Village Board to set an application fee for an appeal of the ordinance and the Village's Legislative and Licensing Committee has recommended that the application fee be set at \$25.00 to cover, in-part, the Village's administrative costs for processing an application for an appeal and for holding a hearing for such appeal. The costs anticipated to be incurred by the Village likely far exceed this fee and include, but are not limited to, copy costs, record request costs, employee time, and costs for a background check.

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Village of Caledonia that the map entitled Child Safety Zone Map attached as Exhibit A consisting of one page is hereby adopted and such map shall become effective the day after publication of the corresponding ordinance which will be the effective date of the revised ordinance as set forth above.

NOW, THEREFORE BE IT FURTHER RESOLVED, that this Board finds that the locations identified on the map are places where children regularly congregate and consistent with the ordinance and the intent of the ordinance, these places should have restricted zones surrounding them where sex offenders should not be allowed to reside.

**NOW, THEREFORE, BIT IT FURTHER RESOLVED**, that the application fee for an appeal under Sec. 11-2-16(g) shall be \$25.00 and such fee shall be paid in cash or by certified check or money order to the Village of Caledonia at the time of submission of an application for appeal to the Village Clerk.
